CAMP VILLAGE ACCOMODATION TERMS & CONDITIONS

Article 1. Hours of Use of Facilities

Facilities will be available for use from 9:00am Friday July 26th to 11:00am Monday July 29th, 2024.

Article 2. Refusal of Contract of Accommodation by the Lodging Facility

The lodging facilities reserve the right to refuse service or use of facilities (including but not limited to reservation and or contract for use) under the following circumstances. The right to cancel the contract or refuse services or reservations shall apply immediately in the event the following come to light after having entered into a contract of accommodation.

- (1) The person or persons making use of or are attempting to use the lodging facilities are found to have broken any laws or regulations or are found to have or may have the possibility of behavior or conduct against public morals and or public decency.
- (2) It is found that the following $1 \sim 4$ apply to the person or persons making use of or are attempting to use the lodging facilities.
 - ① the person is or was a member of a criminal organization or holds connections to known antisocial groups or organizations.
 - ② the person is part of a corporate entity or other organization known to have controlling interests in criminal organizations or criminals.
 - ③ the person is a member of a corporate entity of which any of the directors are known to members of criminal organizations or other anti-social organizations.
 - ④ the person using the lodging facilities engages in violence, menacing, intimidating, or threatening behavior, makes unreasonable or unrealistic demands of the facility or the employees thereof.
- (3) The facility is unable to fulfil the contract of accommodation due to uncontrollable circumstances such as natural disaster or malfunction of facilities.

Article 3. Cancellation of Accommodation Contract by Guests

- 1. Guests reserve the right to cancel the accommodation contract at any time.
- 2. If the contract is cancelled and the facility is found to have not been at any fault, the following cancellation charges shall apply.
 - Prior to and including May 25th: Free of charge.
 - Between May 26th and June 26th: 50% of camp lodging charge.
 - After June 27th and or failure to arrive without advance notification: 100% of camp lodging charge.

Article 4. Failure to Fulfil Accommodation Contract

In the event the lodging facility is unable to provide the agreed upon lodging facilities to the guest, the facility shall return up to the full amount paid by the guest unless the facility is found to have been grossly negligent in fulfilling its responsibility to the guest. However, this shall not apply if the facility is found not to be at fault.

Article 5. Prohibited Items or Conduct

- 1. The guest shall not bring items or animals which may disturb other guests into the facility. Including but not limited to the following examples.
 - (1) Dogs, cats, birds, or other pets or animals.
 - (2) Flammable items, oils, or any other item that may cause fire. Items which give off a strong on unpleasant smell.
 - (3) Items restricted or prohibited by law.
- 2. The use of open flame, conduct or behavior that disturbs or makes other guestsuncomfortable, and or conducting business or sales activities within the camping area.
- 3. Items and Conduct Prohibited Throughout the Festival
 - (1) The use of umbrellas (umbrellas can become hazardous in strong winds)
 - (2) Smoking within the festival grounds (smoking is only permitted in designated smoking areas)
 - (3) Cans and glass bottles (not permitted even when carried within a cooler)
 - (4) Abandoning or leaving trash

Article 6. Storing of Personal Items and Lost Items

- 1.Guests are responsible for the safekeeping of any cash, valuables, and other personal items during their stay. The facility is not responsible for any theft, loss, damage, etc., of cash or valuables.
- 2.If any guest possessions are found to have been left behind upon the guest checking out of the facility, the possessions will be made available for retrieval through the information tent located within the festival. Any items left after the conclusion of the festival will be given over to the Minami Uonuma Police Department. Please note that any perishable items such as food or items that cannot be stored easily will be discarded.
